Did you know? The **Illinois Angel Investment Tax Credit Program** encourages investment in innovative, early-stage companies to help obtain the working capital needed to further the growth of their company in Illinois. Investors in companies that are certified as Qualified New Business Ventures (QNBVs) can receive a state tax credit equal to 25% of their investment (up to \$2 million).

A total of **\$10 million in Angel Investment tax credits a year are allocated**. Credits will be released by quarter, on a first-come first-served basis. Once tax incentive credits for a particular quarter are exhausted, no further credits can be allocated until the subsequent quarter. The Impact of Community Investment: [Auburn Gresham sets itself up for a revitalization](#)

The shuttered terra cotta furniture showroom near 79th and Halsted streets had sat vacant for decades. Twenty-five graduating classes at Leo High School next door came and went. The building sat almost unnoticed, a persistent sign of disinvestment in the South Side neighborhood. But **Carlos Nelson**, CEO of the Greater Auburn-Gresham Development Corp., or GAGDC, got the keys to the building in 2017 after tracking down the owner in Hyde Park and arranging some "creative financing" to spur redevelopment. This month Nelson and his team will cut the ribbon on **the \$20 million Healthy Lifestyle Hub that includes a clinic and pharmacy and will create an estimated 150 jobs!**

Early Childhood Construction Grant

Governor JB Pritzker has announced \$60 million in capital grant opportunities for Illinois Early Childhood Education providers through the Rebuild Illinois Capital Program. The funding will support the construction, expansion, and renovation of facilities that support early student learning.

The initial grant installment delivers \$60 million to qualifying public school districts and not-for-profit early childhood facilities providing educational, health, social, or child development services to children aged zero to five years old and their families. Centers seeking to increase their capacity to provide care or educational opportunities for children in underserved communities are eligible for up to \$10 million under the Early Childhood Construction Grant. A three to ten percent match is required. Rebuild Illinois, Governor Pritzker's historic \$45 billion bipartisan capital plan, will provide a total of \$100 million in state funding for early childhood education provider grants.

Community Development Block Grants – Economic Development

Grants are awarded on an as-needed basis throughout the year to units of general local government meeting eligibility and program component requirements until all funds allocated to this program have been distributed. All awards in this category are predicated upon project feasibility and a demonstrated need for funds. This will include a review of all sources and uses of funds, an analysis of the recipient's ability to comply with the terms of the program, and a determination that CDBG participation is appropriate. The grant ceiling has been established at \$1,000,000 per award. The grant funds awarded shall not exceed \$10,000 per job for any job that is retained

and \$25,000 per job for any job that is created. For your application to be considered, your entity must be pre-qualified. For more information on pre-qualification, please visit:

Illinois Electric Vehicle Rebate Program

Individuals can now access and complete an application for a rebate under Illinois' EV Rebate Program at:

<https://www2.illinois.gov/epa/topics/ceja/Pages/Electric-Vehicle-Rebates.aspx>. Applications for the first funding round are being accepted starting July 1 and must be postmarked on or before **September 30, 2022**.

Rebate application cycles will be opened and rebates will be issued to eligible applicants subject to availability of funds. Illinois residents that purchase an all-electric passenger vehicle **on or after July 1, 2022**, are eligible to apply for a rebate under Illinois' EV Rebate Program. The following rebate amounts have been set forth in statute:

- Beginning July 1, 2022, a \$4,000 rebate for the purchase of an all-electric vehicle.
- Beginning July 1, 2026, a \$2,000 rebate for the purchase of an all-electric vehicle.
- Beginning July 1, 2028, a \$1,500 rebate for the purchase of an all-electric vehicle.

In addition, a \$1,500 rebate is available for the purchase of an electric motorcycle.

EPA Opportunity for School Districts to Adopt Electric School Buses

EPA is offering \$500 million through the [2022 Clean School Bus Rebates](#) for zero-emission and low-emission school bus rebates as the first funding opportunity. **The deadline to apply is August 19**. EPA will continue to update their page with additional Clean School Bus Program funding information and educational resources.

The Bipartisan Infrastructure Law of 2021 authorizes EPA to offer rebates to replace [existing school buses](#) with clean and zero-emission (ZE) models. The 2022 Clean School Bus (CSB) Rebates process includes SAM.gov account registration, application submission, review and selection by EPA, purchase order submission and request for payment, payment receipt, new bus delivery and old bus replacement, and close out.

DOT Announces Funding for Roadway Safety

The application process is now open for communities of all sizes to apply for Federal Fiscal Year 2022 funding to help ensure safe streets and roads and to address the national roadway safety crisis.

The primary goal of SS4A grants is to improve roadway safety by supporting communities in developing comprehensive safety action plans based on a Safety System Approach and implementing projects and strategies that significantly reduce or eliminate transportation-related fatalities and serious injuries involving pedestrians, bicyclists, public transportation, personal conveyance and micro-mobility users, commercial vehicle operators and motorists. Funding can also be used to support stakeholder engagement in order to ensure that all community members have a voice in developing plans, projects and strategies.

IDNR Grants

The Illinois Department of Natural Resources is accepting applications for two grant opportunities through **Aug. 2**: the Illinois Habitat Fund and the State Pheasant Fund grants. The Illinois Habitat Fund Special Funds Grant Program enhances game and non-game wildlife habitat through projects developed by not-for-profit organizations and governmental entities. The State Pheasant Fund Special Funds Grant Program enhances pheasant habitat through projects developed by not-for-profit organizations and governmental entities.

Funding for both grants comes from the sale of habitat stamps to sportsmen and sportswomen. This year, all applications for these grants will be accepted online through the Amplifund portal.
